03	Percentage of TiO <sub>2</sub>	50 +/- 1% by weight. Plastic grade, Rutile crystal type Du Pont make R104 grade TiO <sub>2</sub> is only preferred. Maximum particle size of the TiO <sub>2</sub> particle should not exceed more than 0.22 micron. TiO <sub>2</sub> particles should have excellent lacing resistance to avoid pinholes even at higher processing temperature.
