3. Submission of Bid

3.1 The bidders, who purchase the bidding document, are eligible for submission of bids in their name only.

4. Bid Security

- 1.1 All bids must be accompanied by bid security (Earnest Money Deposit – EMD) in the form specified in the bidding document. The bids not accompanied with EMD shall be summarily **REJECTED**. The bid security shall be denominated in Indian Rupees of value as specified and shall be in the form of Bank Guarantee from Nationalized or Scheduled Banks or Through RTGS/Fund Transfer (Bank detail is as below for your reference).

The Bid security may be forfeited if

- ❖ A bidder or supplier withdraw its bid during the period of bid validity specified by the bidder/ supplier on the bid form or
