We would like to invite most competitive rates with clear break-up of taxes (if applicable) for annual rate contract for refilling and annual maintenance contract for servicing of fire extinguishers & Breathing Apparatus, as mentioned in the annexure attached herewith, considering following terms and conditions,

- 1) Contract period will be one year for our two units 1) AmulFed Dairy, Near Indira Bridge, Village Bhat and 2) Packaging Film Plant, GIDC, Sector 25, Gandhinagar.
- 2) Servicing of Fire Extinguisher & Breathing Apparatus will be required by every two months. You should follow the IS 2190 : 2010 specification for the servicing procedure. You will have to submit the service report to our concern engineer/in-charge at AFD & at PFP within one week of service, and stick the sticker on each cylinder for service date & due date for next service.
- 3) You should carry out refilling work for each Fire Extinguisher and Breathing Apparatus & return it within 7 working days. If you fail to provide refilling of any Fire Extinguisher & BA Set we will get it refilled by other agency and charges will be debited to your account. You will bear (if any) Transportation charges considering refilling works.
- 4) You have to keep our fire extinguishers ready for fire fighting. You will arrange for any spares (if required) in consultation to our concern engineer/in-charge at AFD & at PFP, the charges for spares will be paid extra at actual.
- 5) Kindly submit your rates as per attached annexure only. Prices offer by you shall be for, 1) AmulFed Dairy, Near Indira Bridge, Village Bhat & 2) Packaging Film Plant, GIDC, Sector 25, Gandhinagar. GST would be extra. We will not pay any cylinder/ trolley holding charges.
- 6) **The offer should reach in sealed cover on or before 29.11.2024**, super scribing on the top left-hand corner offer for inquiry no: AFD: PUR: YKV: ENQ: Fire Ex: 2024. We will not accept the offer after due date. Offer received after due date for whatsoever reason may be rejected.
- 7) Offer should be valid for acceptance for 90 days from due date for submission of offer. Rates mentioned should be valid for one year.
- 8) It is not binding on us to accept lowest offer AmulFed Dairy reserves the right to cancel any/ all offers without assigning any reason.

Scope and Terms Condition

Scope of Service:

You are to depute one engineer and two firemen for every service at AmulFed Dairy and Packaging Film Plant.

All your team members must have Dangri, Safety Shoes, Safety Helmet, Gloves, Goggles and Ear Plug for their protections; you will be imposed penalty of Rs. 5000 for not following safety norms of AmulFed Dairy for each violation.

For detailed safety requirements and guidelines of AmulFed Dairy, please refer Annexure IV

Our industry is a food industry and you are to maintain all material and equipment in neat and clean condition.

You are not allowed to enter any department unless permitted by dairy representative.

Your team will carry out service of fire extinguishers as per guidelines of IS 2190 : 2010 requirement by every two months and apply seal to keep all fire extinguisher ready to use, our engineer/in-charge will communicate any change in schedule to you and accordingly you will provide 6 services during contract period.

For Servicing of fire extinguishers and SCBA set, your engineer and firemen will clean, check and service each Fire Extinguisher SCBA set for its easy operation and proper discharge at all time and will have to maintain a service report card for the same, under guideline of our concern engineer/in-charge at AFD & PFP. You are to give service as per IS guidelines and work guidelines as per attached **Annexure II.**

Your team will have to identify fire extinguisher to be taken for refiling and hydro testing and carry those fire extinguisher to the fire /utility room for further transportation and vice-versa and replace the same in plant area once come back from refiling and hydro testing.

For Refilling, you will carry out refilling work as per guidelines of IS 2190 : 2010 & IS 15683 and refilling of SCBA with air purity certificate. All material used for refilling should be IS mark and to be confirmed with our engineer/in-charge and material test certificate with air purity certificate to be sent to our engineer/in-charge

Hydro testing of fire extinguishers to be carried out at interval as mentioned in IS 2190 : 2010 in consultation with our engineer/in-charge at AmulFed Dairy and Packaging Film Plant. During hydro testing any abnormality found it is to be immediately reported to our engineer/in-charge immediately and fire extinguishers & BA set taken out must be returned within 15 days after hydro testing and painting with hard copy report.

You are to make permanents arrangement for fire extinguisher identification like embossing / engraving / tagging etc. so as to maintain unique register of fire extinguisher.

You have to prepare a history card of the fire extinguishers in consultation with our engineer/in-charge.

After completion of servicing /refilling/hydro testing, you are to submitted field report immediately to our concern engineer/in-charge at AmulFed Dairy and Packaging Film Plant and computerize report/testing certificate within 1 week.

In each service you have to check and service Fire Extinguisher as per SOPs attached in Annexure-II

Payment Terms:

Payment will be made within 30 days against submission of invoice against satisfactory work completion with certification from our engineer/in-charge at AFD & at PFP.

Other Terms & Conditions:

You shall make necessary arrangement (like transportation, labour, charges etc.) for the servicing, refilling & hydro test of Fire Extinguishers at your own risk and cost.

You shall replace our original cartridge in our Fire Extinguisher after completion of service. You shall also refill your own cartridge, while you take away our cartridge for service purpose. For DCP & Foam Type Fire Extinguishers you have to bring refill back to AFD/PFP and refill the Fire Extinguishers. You will have to arrange and supply us spares required for any fire extinguisher during the contract period, the rates per unit are mentioned in attached rate sheet.

AmulFed Dairy reserves the right to terminate the contract without assigning any reason. Decision of General Manager– AmulFed Dairy shall be final and binding to all.

For servicing and maintenance purpose of all fire extinguishers and breathing apparatus located at AFD & PFP you have to deploy team of one fire engineer and two Fireman qualification only and with personal protection equipments like Dangri, Safety Helmet, Safety Shoes, Safety Goggles, Ear Plugs & Hand Gloves etc. No Extra cost will be paid for the same.

You have to carry out Hydro Test of CO2 type Fire Extinguishers and Breathing apparatus cylinder at CCE (Chief Controller of Explosives) approved agency only and test report should be submitted for the same.

Charges for servicing, only cartridge refilling, complete refilling, hydro test with painting and spares will be as mentioned in attached rate sheet which will remain unchanged during the contract period.

During the contract period, if the performance of the contractor is not satisfactory then contract can be terminated after giving two (02) written notices through Registered A.D and in such cases the EMD/ CMD/amount payable may be forfeited. In this regards, no further correspondence would be entertained.

Any dispute between the contractor and the AmulFed Dairy will be settled by mutual discussion only and the decision of the General Manger of AmulFed Dairy shall be final and binding on both the parties. In case a legal settlement is resorted to as a last refuge, the jurisdiction of such settlement will be Ahmedabad only.


9. MANDATORY FOR ALL FIRE EXTINGUISHERS (FE)

- > Hydro testing of FE's every alternate year.
- > Changing of Discharge Hose of FE's as the same becomes hard / every six Months, whichever is earlier
- > Changing of DCP Powder as signs of lump formation is shown.
- > Painting of FE's at the discretion of Client.
- ▶ Replace the Cartridge of the FE's if the weight loss is more than 10 % of the standard weight.
- ➤ CO2 FE's to be sent for refilling if the weight loss is more than 10 % of actual weight.
- ▶ For ABC type FE's, if there is pressure loss, then the same has to be sent for refilling.

Annexure IV: Safety Requirements of AmulFed Dairy

A. <u>GENERAL REQUIREMENT:-</u>

- 1. Contractor must submit Medical Fitness certificates for all the workers after award of contract and before commencement of any work.
- 2. Contractor Owner / supervisor / in-charge must brief these safety guidelines-requirements and other work related safety precautions to all their workers at least once, And record of the same is maintained and submitted to Safety Officer Amulfed Dairy.
- 3. Contractor has to brief and made aware all their workers that they understand the importance of House Keeping and always maintain good housekeeping while work and after work.
- 4. Contractor must follow work permit system / risk assessment authorized by Amulfed Dairy incharge every time before work for all the activities at site.
- 5. For any critical work contractor has to plan properly with in-charge (Amulfed Dairy) and Safety Officer- Amulfed Dairy before work.
- 6. For any controversy or immediate threat to safety of person and plant the decision of Safety Officer Amulfed Dairy is final.

B. DOCUMENTS:-

- 1. Medical fitness certificates of all workers (One Time)
- 2. Equipment's testing and validation record wherever required.

All the documents must be maintained at site and shown to Amulfed Dairy officials on demand

C. <u>PPES:-</u>

- 1. Contractor has to ensure sufficient quantity of following PPEs provided for their workers all the time at workplace and made arrangement for it's upkeepment with effect from first day of contract.
 - a. Safety Shoes
 - b. Safety Helmet
 - c. Cotton Hand Gloves
 - d. Goggles

D. <u>EQUIPMENTS:-</u>

All the following mentioned equipments must be ISI marked and tested / calibrated by Third Party and contractor has to submit testing / calibration certificate before commencement of work.

1. Hand Grinder:-

a. Grinding m/c must be in good condition having no defects

- b. Having identification and testing labels on it
- c. Guard must be there always on the grinding wheel
- d. Body earthing if metal body
- e. Having given body earthing and always connected with ELCB
- f. Having intact supply cable with top plug and no joints allowed

2. Hand Drill and other portable tools:-

- a. Hand Drill and other portable tools must be in good condition having no defects
- b. Having identification and testing labels on it
- c. Guard/lock must be there always on the machine
- d. Body earthing if metal body
- e. Having given body earthing and always connected with ELCB
- f. Having intact supply cable with top plug and no joints allowed

3. Extension Board:-

- a. Sufficient Number of Portable Extension provided by contractor
- b. All the extension board have proper fiber cover
- c. All the extension must have 1 female plug of industrial type 3-phase, 1 female plug of industrial type 1-phase, 1 female plug of three-pin
- d. Extension boards having provision of earthing wire
- e. Extension board must have RCCB / ELCB on it
- f. Having intact supply cable with top plug and no joints allowed

E. SAFETY GUIDELINES FOR WORK:-

1. <u>Maintenance / Servicing Work):-</u>

- a. Use of Safety Shoes, Safety Helmet, Cotton hand gloves, Goggles is must for all the workers.
- b. Ensure proper isolation of equipment and permission of respective Amulfed Dairy in-charge.
- c. Do service maintenance as per standard procedure or as per guideline of Amulfed Dairy incharge.

F. <u>PENALTY:-</u>

- 1. For Not following General Requirements, Penalty of Rs. 5000 for each violation / per day will be imposed.
- 2. For non availability and fulfillment of above listed documents penalty of Rs. 2000 for each violation / per day will be imposed.
- 3. For not using required PPEs at work, Penalty of Rs. 2000 for each violation will be imposed
- 4. For not following any Safety Guidelines while work for relevant work, Penalty of Rs. 5000 will be imposed.
