7. The waste lifting party will have to abide by the directives of the AmulFed Dairy with regard to conduct and movement of his workmen in AmulFed Dairy premises.
8. The waste lifting party has to remove and replace forthwith such of the workers who are found to be undesirable by the AmulFed Dairy. The Contractor shall be solely responsible for the acts of omission and commission of his workmen deployed for carrying out this work and shall indemnify the AmulFed Dairy against any damage to property and injury to limbs and loss of life of person(s) arising out of negligence and
