5. Your submitted offer must be valid for one year, as this is the yearly contract & no price hike will be given during rate contract period.
7. The price should be quoted on F O R destination, applicable GST extra on proposed rate. However it should be clearly and separately mentioned in your offer. Non indication of above levies will mean that prices are inclusive of all taxes and above levies.
8. Realistic and earliest response time should be indicated in offer.

## Annexure 1 TERMS & CONDITION

1. Each unit will be provided 6 (six) routine services (Preventive maintenance Visits) in a year. This will be done bimonthly by your authorized & trained mechanics.
2. You have to provide unlimited nos. of breakdown calls during the contract period. You have to attend breakdown call within 24 hours from receipt of our call.
3. The following routine servicing will be covered during planned visit:
  - a. Checking operational performance parameters.
  - b. Cleaning of blower, condenser fan, air filter, evaporator & condenser coil and other equipments.
  - c. Oiling the motor if required.
  - d. Verification of installation.
  - e. Gas Charging free of cost
4. Your Service person has to come by giving prior intimation & after completing the service he must take the authorized signatory from respective AmulFed Dairy employee on the service report & have to submit one copy to AmulFed Dairy respective department.
5. You shall undertake the repairs & supply of all the spares & material required for the machine free of charge under this contract.
6. In case of replacement of parts required during the contract than you have to replace Faulty part with original **parts from Original equipment manufacturer only**.
7. below mentioned items shall not be covered under this contract,
  - Outer Casing, Coils, Front Panel, Grill, Stabilizer Parts.
  - All Sheet Metal Parts.
  - Any shifting/reinstallation needed for air conditioners.
8. Force measure clause: You shall not be liable for any breach or non performance or delay in carrying out any of the obligations contained in this maintenance service leaflet including servicing/repairing of the unit as result of strike, lockout industrial labor disturbance, fire, accidental damage, restriction imposed by the Government circumstances beyond our control, any act of God, riot any war or any condition arising from similar caused beyond our control.
9. Renewal of the Service Contract after its expiry will be on mutual concern of both the parties.
10. We reserve the right to terminate this contract for maintenance if your service is not found to be satisfactorily.
11. The unit at the changed location or its service/repair etc. in any manner by any other party shall not be done without prior information to you.

## General Rules

The supplier has to ensure that their vehicle coming to AFD/PFP Should be:

- a) PUC certified vehicles having valid PUC requirement
- b) Vehicles should be properly maintained with no leakage of oil from engine/gearbox.
- c) Preferably vehicle should be closed to avoid aerial contamination
- d) Use of energy efficient vehicles and technology for manufacturing of goods/material
- e) Your Vehicle must carry fitness certificate issued by a competent authority like RTO etc.
- f) We wish to inform you that during our surprise checking of the vehicle, if we observe any violation, particularly regarding PUC certificate and driving licence, we would be constrained to impose a penalty of Rs 500 per incident for first 2 incidents. If we observe repetitive reoccurrence of such incidences, entry of such vehicles would be stopped.

## General Safety Rules:

- a) Do not carry any kind of flammable materials like a matchbox, lighter, stove, SIGRI etc.
- b) Cigarette and eatables like Gutkha, Pan Masala etc within the company premises. In any case, if someone found with Gutkha/Pan Masala/ Cigarette, then AFD/PFP will impose a penalty of Rs. 5000/- and entry of particular person shall be permanently prohibited in the premises. It is applicable to all carriers/drivers/ any representatives of vendors/bidders/suppliers/service providers or any visitors.
- c) Do not enter any plant area without permission
- d) Do not do an unsafe act
- e) Do not use a mobile phone at tank farm and any plant area.
- f) Do not take photographs in the company
- g) Do not enter without Helmet and shoes in any plant area.
- h) Park your vehicle at the designated parking area.
- i) Meet only authorized person for which you have taken permission.
- j) Follow work permit system wherever required
- k) Ensure safety devices/accessories on your machines and equipment
- l) Use work specific PPEs
- m) Follow safe material handling practices
- n) Display Visitor I-Card on your shirt pocket
- o) We invite your attention towards our Safety, Health and Environment Policy
- p) Violation of Safety norms will attract heavy penalty
- q) If you hear an emergency siren, do not panic and talk to company employee for actions to be taken.
- r) Types of Siren
  - " Alert siren: Single continuous siren for one minute.
  - " Evacuation siren: Waiting & waning siren for three minutes
  - " All clear siren: Long continuous siren.
- s) As soon as you know about emergency try to reach nearby assembly point as per factory drawing.
- t) In case of gas leakage, move in a crosswind direction
- u) Don't go at the emergency spot
- v) Before entering the Dairy premises first get acquainted yourself studying the site layout map displayed at Time Office
