5) Offer received after due date for whatsoever reason may be rejected. **Offer should be valid for acceptance, for minimum 90 days from the date of submission** i.e. Due Date. Validity of rates should be for one full year as this is rate contract for Complete one year.

6) packing & forwarding, freight etc. However **it should be mentioned clearly and separately in your offer**. (FOR destination is as mentioned above. - term no.3).

7) **You should quote the discount structure very clearly**. No price hike will be given during the period of rate
