- 1) The Offer should be sent in sealed cover super scribing on the top left-hand corner, **Offer for Inquiry No: AFD: PUR: ENQ: 2022: 88**
- 2) Offer should be sent through Post or Courier, **NOT BY** Fax or Personally.
- 3) **EMD**:-You will have to deposit INR 10,000 EMD by the way of DD/NEFT /RTGS drawn in favor of AmulFed Dairy (A unit of GCMMF LTD.) payable at Ahmedabad only. In case your quotation is not accepted the EMD will be refunded within a month from the date of finalization. EMD will carry no interest. In case successful bidders, does not turn out for signing the contract or does not respond to the contract, the EMD already paid shall be forfeited and no claim will be entertained and decision of General Manager, AmulFed Dairy shall be considered as final.
- 4) **Security Deposit**: In case your quotation is accepted and converted into the work order, your EMD will be converted into security deposit and you will have to deposit additional security deposit amount Rs.10,000/- bank guarantee by the way of demand draft drawn in favor of AmulFed Dairy (A unit of GCMMF LTD.) payable at Ahmedabad of any Nationalized Bank / Reputed Private bank (like ICICI, HDFC, YES BANK, AXIS BANK) only. This will earn no interest. SD to be arranged within a period of 7 days from the date of receipt of intimation from us. It will return after the successfully completion of your work order.
- 5) **Due Date: 05th Feb, 2022**. Offer received after due date for whatsoever reason may be rejected. Offer should be valid for acceptance, for 45 days from the date of submission i.e. Due Date. Validity of rates should be for one full year as this is rate contract for one full year.
- 6) The price should be quoted on F.O.R. AmulFed Dairy basis – inclusive of all applicable taxes, packing & forwarding, freight etc. However it should be mentioned clearly and separately in your offer. FOR destination is as mentioned above.- term no. 1
- 7) No price hike will be given during the period of rate contract and price will remain fixed during contract period. We would prefer payment term - within 30 days from receipt of material or invoice whichever may be late.

Approximate qty is **25,000 meters per month** for AFD and 5000 for PFP i.e. **AmulFed Dairy, Bhat** and **PFP**, Near Madhur Dairy, G.I.D.C., Sector 25, **Gandhinagar**. Quantity may increase or decrease.
- 10) **Specification: weight should be Min. 2.2 Kg per 100 meter of cotton cloth should be required.**
- 11) **Supply will have to be made to both the above-mentioned units, as per requirement**
- 12) Realistic earliest delivery period should be indicated. The equivalent amount shall be debited to your account if shortage or defect considering quantity or quality is observed in your supply. You will supply the material as per our required qty & date. If you fail to supply the material and due to stock out of said material at our store, if we are forced to procure the material from other supplier the difference of amount will be debited to your account.
