Technical Submission :

- Technical submission will be allowed through purchase portal only.
- Vendor who do not have purchase portal id can visit our website <https://afdpurchase.amul.in/> and apply for registration.
- After registering vendor must send mail to umang.vanani@amul.coop for patriciate in inquiry for getting RFQ for technical submission.
- Our technical officer will review your specification and will provide decision for approve or rejection in purchase portal only.
- Once your technical specification gets approved you will be allowed to submit commercial bid in purchase portal.
- On Approval of your technical specification, you need to send one pair of safety shoes for evaluation.
- Shoes of must be submitted to AmulFed Dairy address.
- Sample Box must be mentioned with inquiry no. to identify and handle separately.
- Sample submitted of shoes will be returned once it will be reviewed.
- Sample of vendor whom we will award order will be kept with us for base Sample for order.
- You must submit EMD of Rs. 10,000 with your commercial bid. Bid without EMD will be rejected.

Commercial Quotation submission:

- Quotation must be submitted in purchase portal only any hard copy or mail quotation will be rejected and will not be considered for any process.
- Your rate must be valid for delivery of shoes for 2 years. We will take majority of order quantity in first delivery after that we will take delivery in small part as per our new employee join the organization.
- Commercial bid must be submitted for door delivery only. Vendor will be liable for replacement of shoes at site with all cost of replacement at vendor account. AmulFed Dairy will not bear any cost for replacement.

Terms to be considered for fullfiling order

- One sample of all sizes of shoes from size 4 to 14 must submitted on receipt of order to provide size wise quantity sharing for delivery of shoes against order.
- Size wise bifurcation of Antistatic and Electrical shoes will be given after size measurement process.
