- 7) You have to lift milk sludge with in terms of confirm order/contract. AmulFed Dairy reserves the right to extend the contract, if necessary, for the period of maximum 3 months on the same terms and conditions.
- 8) The terms and conditions mentioned in this tender form would be integral part of the contract being executed between the parties. The milk sludge should be lifted as per instruction from the premises of AmulFed Dairy on "As per Contract terms" by you at your expense. No segregation of the material will be allowed at our premise while lifting of the milk sludge.

- 9) The milk sludge should be lifted in any working day between 10 a.m. to 3 p.m. or as per schedule given by us without fail. Failure to lift the milk sludge everyday shall invite penalty on the contract as deemed fit by the management of AmulFed Dairy. It will be contractor's responsibility to keep milk sludge volume zero at AmulFed Dairy, once contract is awarded.
- 10) Before lifting of milk sludge from AmulFed Dairy you have to deposit RTGS of equivalent amount at AmulFed Dairy's Account's department. The necessary receipt in advance should be produced and then only you will be allowed for lifting the of the milk sludge. The milk sludge should be collected from our premise by your own arrangements. All the types of weightment / counting or measurements & loading would be done at AmulFed Dairy in the presence of our authorized person & shall be considered as final.
- 11) The contractor will take due care in performance of the contracted work in time & shall engage adequate personnel and tanker to ensure the same. The contractor shall not make any loss/ damage caused by the workmen engaged by them to the properties of AmulFed dairy.
- 12) The contractor will have to abide by the directives of the AmulFed Dairy with regard to conduct and movement of his workmen in AmulFed Dairy premises.
- 13) The Contractor has to remove and replace forthwith such of the workers who are found to be undesirable by the AmulFed Dairy. The Contractor shall be solely responsible for the acts of omission and commission of his workmen deployed for carrying out this work and shall indemnify the AmulFed Dairy against any damage to property and injury to limbs and loss of life of person(s) arising out of negligence and carelessness on the part of his workmen while carrying out his work and the cost of such damage/loss shall be recovered from the contractor.
- 14) The Contractor will be responsible for any Govt. rules and laws applicable in connection with their workmen and AmulFed Dairy will not be responsible for the same.
- 15) The milk sludge shall be lifted daily without fail. If milk sludge is not lifted as informed, the same shall be disposed off by us at prevailing prices and loss occurred due to this to AmulFed Dairy in sale of milk sludge, transportation, loading etc. shall be recovered from or will have to be paid by contractor. Penalty of 10% of the invoice value of the scrap disposed off shall be recovered from the contractor.
- 16) The AmulFed Dairy would be free to engage service from outside or/ otherwise to the work, in the event of contractor, fails to perform the work and all cost, damages, if any on this behalf shall be entirely to the account of the contractor as explained above.
- 17) During the contract period. If the performance of the contractor is not satisfactory then contract can be terminated after giving two (02) written notices through Registered A.D.
- 18) Any dispute between the contractor and the AmulFed Dairy will be settled by mutual discussion only and the decision of the General Manger of AmulFed Dairy shall be final and binding on both the parties. In case a legal settlement is resorted to as a last refuge, the jurisdiction of such settlement will be Ahmedabad only.
- 19) Management reserves the rights to accept or reject any/ all bids offered by bidders, without assigning any reasons. Management decision in this regard would be considered as final and binding to all. No further communications/ complaints will be entertained in this matter.
- 20) AmulFed Dairy, Bhat reserves the right to award contract on one or more parties as deemed fit by the management and same shall be binding to all bidders.
