## ANNEXURE-1 Terms and Conditions

Terms & Conditions for Transportation Contract for the internal transportation of Milk within the premises of AmulFed Dairy, Plot No. 35, Ahmedabad - Gandhinagar Highway, Village Bhat-382428, Dist: Gandhinagar.

- 1. This tender is explicitly for the transportation contract for the internal transportation of Milk within the premises of AmulFed Dairy, Plot No. 35, Ahmedabad-Gandhinagar High way, Village Bhat-382428, Dist: Gandhinagar
- 2. Period of the contract shall be from Jan 1st, 2025 to Dec 31st, 2025.
- 3. Rates of the contract for the internal transportation of milk within AmulFed Dairy premises shall be for 20 25 KL capacity tanker on lump sum basis. However you may deploy tanker of higher capacity on your own, at same approved rates.
- 4. At present there is a requirement of two tanker for the internal movement of milk during the contract period without fail. You will be liable to provide more number of tankers for the internal movement of milk at the rates mentioned in this contract as required by AmulFed Dairy during the contract period from time to time. Requirements of tanker may decrease or increase, based upon our actual requirements.
- 5. The aforementioned rates are valid for 01/01/2025 to 31/12/2025 from the date of award of contract. During the contract period, AmulFed Dairy shall not give any fuel rate hike on regular basis. In extreme condition, it will be reviewed only once in contract period on 01.06.2025 against current rate of diesel of Rs. 90.38/Ltr as on 18.11.2024. This clause is applicable as there is a change in fuel rates higher/lower than Rs 2/Liter from the date of finalized the contract/ last price revision date. For consideration of Diesel price change, we will follow rates mentioned in the IOC website for Gujarat State Civil Supplies (GSCS), Gandhinagar location. - 6. The Transporter shall strictly deploy fully SS Insulated Tankers for the transportation of Milk within the premises of AmulFed Dairy, Gandhinagar.
- 7. The Transporter shall be responsible for the safe transportation of Milk within AmulFed Dairy premises. Any loss due to damage theft, accident during transit shall be borne by the Transporter. Transporter shall take full insurance policy for the Tanker provided.
- 8. AmulFed Dairy reserves the right to terminate the contract, without assigning any reason, by giving 15 days prior notice to the transporter. Decision of General Manager, AmulFed Dairy shall be final & binding on the transporter.
- 9. Ahmedabad jurisdiction shall be applicable for any discrepancies or dispute.
- 10. In case of non-availability of driver or breakdown of truck, AFD shall arrange the same from other tanker transporter and AFD shall deduct per incident Rs. 400/- for driver deployment and Rs. 1000/- for trip which shall be passed on to the transporter/driver who has provide vehicle or help to move the tanker.
