Eligibility Criteria :

- 1) Bidder should be having minimum five successful installation of similar nature/capacity.
- 2) The Bidder/Supplier shall have turnover, in each of the last three years, at least 10 crores and must have executed, in the last three years at least one contract of similar nature.

- 3.1 The bidders, who purchase the bidding document, are eligible for submission of bids in their name only.

Submission of Bid :

The bidder who has downloaded the bidding document from the site, and fulfilling above eligibility criteria eligible for submission of bids in their name only.

- 1.1 The bid shall be submitted through hardcopy/mail/telefax before above due date is acceptable.
- 1.2 The Price Break up sheet (in separate sealed Envelope, if send through hardcopy) and technical document shall be submitted at the office address mentioned below.
- 1.3 The price Break up sheet should be entitled with reference of "Price Break Up for Design, supply, installation, testing and commissioning of Paneer manufacturing Line with all accessories.

Bid Security (EMD)

- 2.1 All bids must be accompanied by bid security (Earnest Money Deposit – EMD) in the form specified in the bidding document. The bids not accompanied with EMD shall be summarily rejected.
