#### **Scope in transport :**

1. Crates with Pizza base from Sumul (Navi pardi) plant need to bring AmulFed Dairy
2. Empty Crates from AmulFed Dairy need to return to Sumul (navi pardi) plant

Ref. diesel rate will be of 01.08.2022 , Rs. 92.38 per liter

Note : if need arises Diesel prices will be reviewed 1<sup>st</sup> of every month taking Ex gandhinagar IOCL reference and if there is change above +/- Rs. 2 we will be revised the rates upward/downward considering vehicle average of 12 Km/Liter.

Default payment terms will be 30 days credit after submission of invoice along with acknowledge LR copy from concern receiver.

## ANNEXURE - 2

### **TERMS & CONDITIONS FOR PIZZA BASE TRANSPORTATION FROM SUMUL (NAVI PARDI) TO AMULFED DAIRY: -**

1. These rates will remain in force for the period of 12 months (**1<sup>st</sup> Sep. 2022 to 31<sup>st</sup> Aug. 2023**)

Contract is for transportation of Pizza base. Vehicle deputed must be safe for transportation of such Goods. Vehicle must be properly cleaned and maintained Hygiene condition for safe trip. NO vehicle to be deployed which are earlier used for carrying Chemicals, Pesticides, Drugs, medicines or any hazardous material.

2. Following Points need to consider by transporters while sending the vehicle. If any point not fulfill then we will not allow the vehicle for loading.

- a) Vehicle will be inspected at Gate by Security and QA person. If vehicle will be found not fit for loading, it will be returned, intimating to Driver, Bilty person and Dispatch official. Transporter have to depute another vehicle ASAP. To avoid such situation, Transporter have to ensure proper vehicle and instruct driver for below requirements.
- b) The Surface of Vehicle should be neat & clean and smooth, uneven/ protruding surface on sides or extended body will not be accepted as it could damage our product during transportation.
- c) In Vehicle no smell/odour should be there.
- d) Vehicle should be in closed condition. In Vehicle tarpaulin should be neat & clean and without any tears/holes. Tarpaulin must be sufficient to cover material from Bottom, both sides and top.

3. AmulFed Dairy, Gandhinagar shall have an option to extend this Transport Contract for a further period of three calendar months on the same freight rates and terms and conditions.
4. The transport carrier shall deliver the goods at the destinations in safe and sound condition. The transport carrier must use tarpaulin and/or other suitable cover to protect the consignment from Sun/rain/water/dust etc. and the same should be maintained throughout the transit.
5. Blacklisted vendors by AmulFed Dairy cannot participate in bidding process. Bids received from these vendors would be rejected.
6. It is transporter's responsibility to collect 'material received receipt' / acknowledge LR copy from consignee. Based on this receipt only, transporters' bills payment will be made. **Any damage, short receipt or Remark on LR by recipient should be immediately communicated to AmulFed Dairy via email.** It is transporter's responsibility to deliver empty crate to Sumul (Navi Pardi) and collect 'empty crate received receipt' / acknowledge to send to AmulFed Dairy.

7. All trucks to be supplied should be totally insured and as per RTO rules & regulations, if any duty / fee / tax / toll tax / road tax is payable then it is sole responsibility of transporter/ contractor to observe and clear all formalities.
8. For any accident, transporter or contractor is responsible. Any Material / Vehicle / Life will be to transporter's account in case of accident. Material / Pouch Film rolls if damaged due to accident then actual damage cost plus Rs.5000/- per accident as fine will be recovered from transporter/ contractor either by direct payment or from security deposit or from monthly bills. In case of accident, transporter / contractor has to inform AmulFed Dairy Authorities immediately. Recovery of goods from accident site to be taken by transporter and damage assessment to done at the destination by the consignee.
9. In AmulFed Dairy premises, transporter's representatives / drivers / cleaners etc. have to follow and has to abide by Dairy rules & regulations for hygiene / discipline with proper behavior. The driver should have valid Driving license. chewing and spitting of Guthka, **consumption and possession of liquor** in the premises PAN, Gutkha, BIDI, Cigarette is strictly prohibited in PFP premises. If Driver or Transport person found carrying , consuming or spitting in factory premises, it will be fined for Rs. 5000/- each incidence. . In case of non compliance of these rules, financial penalty of minimum Rs 5000/- and returning of the vehicle would be resorted by the AFD-PFP depending on case to case basis.
10. Delivery of pizza base to AmulFed Dairy must be in time without any delay and without damage. AmulFed Dairy shall recover total cost for damage as penalty per such incident from transporter / contractor.
11. It is transporter/ contractor's responsibility to deliver the given material to consignee without any wastage / damage/ theft/ shortage and violation of this condition will be recovered from your Invoice for such matter / event from transporter/ contractor.
12. As we shall be giving you full truckload consignments, you will ensure that no foreign goods are transported along-with our consignments. No transshipment and partial shipment of material is allowed. Payment would be forfeited, if found so.
13. Please note that we have registered your name as our approved carrier purely on trial basis. Please ensure to provide Truck as per your commitment, we may cancel your registration, if your services not found satisfactorily.
14. The responsibility of reporting to the point of origin for loading lies with carrier. The transport carrier shall make available the Vehicle in stipulated time frame as per demand. In case of delay in placing the vehicles by more than 24 hr from the demand time, AFD reserve the right to arrange the vehicle from open market rate and differential amount will be recovered from the transporter. AFD will charge the penalty of Rs.500/- for second time delay and for subsequent times in a month to deploy the vehicle.
15. During the tenure of this contract, any transport carrier denies to lift our goods at our approved rates, AmulFed Dairy, Gandhinagar would immediately arrange vehicle from the open market and the difference would be recovered from the transporter's pending freight bills. We also keep our right reserve to withhold carrier's freight bills till end of the contract.
16. If vehicle becomes immovable on road in transit due to breakdown or accident, then alternate arrangement is to be done by contractor/ transporter.

17. All vehicles should be PUC certified and environment friendly as AmulFed Dairy is ISO - 14001, ISO 9001, FSSC, FSMS: 22000 certified unit. In the interest of sustainable environment, we urge you to deploy eco-friendly trucks.
18. If in extreme case, it is required for calculating Price increase / decrease in Per Trip charges at the time of fuel price increase / decrease after date of contract /order/ agreement are to be calculated on the basis of kilometer in Inquiry plus taking 12.0 km/ liter as average for vehicle. This clause is applicable if diesel prices undergo change (upward or downward) more than cumulative Rs.2 per liter as announced by GOI during tenure of this contract, then the approved rates shall be adjusted downward or upward by the savings or additional burden in diesel cost due to such diesel price changes. (Reference price shall be considered as price 01.08.2022 is Rs 92.38/Ltr. / Liter of diesel at Gandhinagar). This will be reviewed on 1st of every month.

All bills should be submitted within 30 days of consignment delivery. Freight will be paid within 30 days after submission date. Further, if any bills are submitted after 90 days of consignment delivery – the same will not be considered for payment.
21. For any dispute regarding this Inquiry / contract / agreement, Ahmedabad is the jurisdiction.
22. Transporter / Contractor has to maintain PF / BONUS / LEAVE / ESI accounts of his representatives / workers employed by him on his sole responsibility and AmulFed Dairy is not at all involved and Dairy will not be responsible for any thing in this matter.
23. Rates given by you is considered to be inclusive of all taxes, waiting charge, drivers/ cleaners' salary – allowances- fuel (diesel), oil, truck maintenance, any govt./private levies etc. Trip means covering all maximum possible points between two destinations.
24. Any Remarks on LR must be intimated to AmulFed Dairy immediately.
