## Technical specifications for HDPE pipe supply and installation

### Scope of Work:

Scope of work covers supply of HDPE pipes & fittings, unloading at site, laying, testing and commissioning of 125 mm OD HDPE pipe in garden (above ground) of AmulFed Dairy, Gandhinagar. All arrangements for lifting tools & tackles for unloading and installation shall be in the scope of supplier.

## **Technical Specifications:**

Broad technical specifications of work are as under:

- HDPE pipes should be DN-40, PN-10, PE-80 grade. Pipe will be in coil form to facilitate quick installation along the compound wall of our premises.
- Pipes and accessories should be of reputed make, having proven installations in dairy plants. All supporting documents for approval of pipe makes in similar kinds of work should be enclosed along with the offer.
- All the pipes and accessories should be suitable to "Electro fusion" jointing. All joints should be made by electro fusion welding.
- Further details for installation of at Annexure I. Bidder should quote the unit rates for supply and installation of pipes and accessories. Final payment shall be made based on joint measurement sheets.
- Rates should include cost of nuts, bolts, gaskets and other such miscellaneous items, including fabrication of supports at few overground lines.
- All pipes shall be hydro tested at the pressure rating of pipes.
- All material shall be guaranteed against manufacturing defects for a period of 12 months from the date of commissioning.

#### **Time Frame:**

Successful bidder shall visit the site within a week of receipt of PO and finalize the route lengths as well as requirement of accessories. Material shall be supplied within 2 weeks and the entire work shall be completed within maximum time frame of 6 weeks.
