We would like to invite most competitive rates for sale of Broken used Crates under following terms and condition, **for a contract of one year on variable rate basis.**

- Contractors will abide by & bound to follow all the terms, conditions mentioned here in this tender.
- **Due date is 01.06.2020** for submission of offer for scrap item. Offer to be sent to mail on yagnik.vyas@amul.coop before 6 PM and copy to sunil@amul.coop and bhaskar.gadani@amul.coop
- In case of requirement for further details of scrap material, you may visit between 2:30 PM to 4 PM for during tender period (Excluding Sunday/Holiday)
- Approximate monthly average quantity would be 10,000 Kgs (indicative figure only). The scrap material should be lifted minimum twice in a week. There must be minimum fifteen lifting counts in a month. Failure to lift the material shall invite penalty @ Rs. 1500/- per count which will be adjusted from the amount payable by you OR security deposit. The management can solely decide applicability of this clause, without any precedence and it would be binding to bidders.
- You should lift the scrap material from the premises of AmulFed Dairy, At & Post: Bhat Village, on "**AS IS AND WHERE IS BASIS**" at your expense. No segregation of the waste material will be allowed at our premise while lifting of the scrap material. If you fail to lift the material within committed time period, your EMD/SD will be forfeited. The amount for material to be collected, as well as the applicable tax amount should be deposited by way of E transfer
- Any applicable Taxes, Excise levies etc. will have to be borne by the contractor and the rates are EXCLUSIVE of all the taxes. (Ex. AFD)
- EMD is Rs. 2,50,000.00 (Rupees two lac fifty Thousand only). Offer without EMD shall be summarily rejected without assigning any reason. You can transfer EMD electronically to our account "BANK NAME: HDFC BANK, ACCOUNT NAME: AMULFED DAIRY (A UNIT OF GCMMF LTD), A/C NO: 00060310001593, BRANCH: NAVRANGPURA, IFSC CODE: HDFC0000006." **You have to ensure that EMD amount must have reflected in our account before tender submission time.** You have to provide RTGS/NEFT details to AFD in advance before tender submission like UTR no.AFD shall not accept tender without require information. Any delay in deposition EMD by electronic mode/NEFT/RTGS shall be your responsibility
- For existing scrap vendor, we may consider their existing balance deposit for scrap contract again new tender. If total EMD of offered items are higher than available balance deposit, vendor has to submit additional deposit for differential amount. You have to provide details for consideration of existing EMD to be considered.
- You will take due care in performance of the contracted work in time & shall engage adequate personnel to ensure the same. You shall not make any loss/ damage caused by the workmen engaged by you to the properties of AmulFed Dairy. You will have to abide by the directives of AmulFed Dairy with regard to conduct and movement of your workmen in AmulFed Dairy premises.
- You are requested to submit rates as per attached ANNEXURE only.
- **The basic rates of broken crates will vary based on the basic rate of HDPE Grade M60075 of M/s Reliance Industries Limited. This rate will be reviewed on every 01st day of the month and any upward or downward revision of the rate will be effective on prorata basis from 3rd day of month(T+2). The prevailing rate of said grade of M/s Reliance Industries Limited on 01.05.2020 (Rs 68,894 per MT) (Pricing zone Ahmedabad, Domestic price for hazira HDPE Grade) will be considered for calculation and any upward or downward calculation will be done accordingly.**

- It may not be binding on us to award order on highest offer basis. AmulFed Dairy reserves the right to accept or reject any/ all offers without assigning any reasons. Decision of General Manager – AmulFed Dairy, in this regard would be considered as final and no complaints will be entertained.
- There is no guarantee given here for selection of tender on highest offer basis. Management reserves its rights to reject any/all offer without assigning any reason. We reserve our right to award contract on one/more than one parties, as deemed fit by management and same will be binding to participating bidders.
- Before submitting the tender, contractor may visit at AmulFed Dairy Gandhinagar to see the waste.
- Parties/ Vendors, which were blacklisted by AmulFed Dairy, shall not be considered for awarding contract. If it comes to knowledge of AmulFed Dairy that such blacklisted Parties/ Vendors have submitted offers by other names OR in the name of their sister concern firm, their offer shall not be considered.
- During the contract, if the performance of the contractor is not satisfactory then contract can be cancelled after giving two (2) Regd. A.D. written notices & in such cases the EMD /SD will be forfeited.
- The bidder must give his own FAX No., active email ID, land line number and mobile number of the authorized person for communication. If provided information is not clear OR inadequate then AmulFed Dairy reserves right to cancel the bid. After awarding the contract, the contractor must maintain these communication facility live, failings to do so shall be penalized @ Rs. 1,000/- charge or even may lead to termination of contract.
- AFD strictly prohibit use of Tobacco in dairy premises in any form. Such acts will be strictly penalized @ Rs. 5000/- per act along with to permanent no entry to the driver, cleaner or any of your workers identified.
- All pages of tender including rate sheet must be signed & sealed by contractors which are considered as your acceptance for all rates, terms & conditions mentioned in tender.
- We are an ISO 9001:2015, 14001:2004 and ISO 22000:2005 certified unit. We follow eco-friendly processes, which helps in sustainable & safe up keeping of an environment. We also encourage renewal energy like solar. We expect same procedure to be followed in your unit. Please ensure maximum recycling of material lifted from AmulFed Dairy. We are also committed for food safety and human safety on highest level.
- You will ensure that scrap materials lifted from AmulFed Dairy are not used in harmful activities for environment. You shall submit, in writing, disposal plan for the material being lifted from AmulFed Dairy.
- Management reserves the rights to accept or reject all/any offers submitted by bidders, without assigning any reasons. Management decision in these regards would be considered as final and no complaints will be entertained.
- Any dispute between the contractor and the AmulFed Dairy will be settled by mutual negotiations only and the decision of the. General Manager, AmulFed Dairy shall be considered as final and binding on both the parties. In case a legal settlement is resorted to as a last refuge, the jurisdiction of such settlement will be Ahmedabad only.
- We reserve our right to extend the contract duration further by 45 days or increase or decrease the quantity allotted as per the contracted rates and terms with mutual consent.
- **You should have valid GPCB registration certificate / consent for disposal/ recycling of waste material being lifted from AmulFed Dairy.**
