1. Eligibility Criteria

- 1.1. The bidder/sub-vendor must have Supplied, Installed & Commissioned at least one Aseptic Milk/Cream packing line of similar nature & similar capacity globally in the last five years.
- 1.2. Bidder/Sub-vendor must have a minimum turnover equal to the value of project for any of the last 3 years.
- 1.3. Bidder/Sub-vendor company registration/incorporation must not be less than or equal to 5 years from the date of bidding.

1.4. Bidder/Sub-vendor must have manufacturer's authorization for packing machine OR they shall be a manufacturer of packing machine.

2. Purchase of Bidding Document

3.1 The bidders, who purchase the bidding document, are eligible for submission of bids in their name only.

4. Bid Security

4.1 All bids must be accompanied by bid security (Earnest Money Deposit - EMD) in the form specified in the bidding document. The bids not accompanied with EMD shall be summarily **REJECTED**. The bid security shall be denominated in Indian Rupees of value as specified and shall be in the form of Bank Guarantee from Nationalized or Scheduled Banks or Through RTGS/Fund Transfer (Bank detail is as below for your reference).

- In case of successful bidder/ supplier, if the bidder/ supplier fails to sign the contract.
