### **Details scope of work for Servo System In IS-6 FFS M/C are as below**

- 1) Puller System should operate through Servo, PLC & HMI with eye mark sensing system on different operation mode like Photo-Off- Plain.
- 2) Production data should be available on HMI
- 3) HMI should operate & data should reset through password only
- 4) Batch counter & volume size should be set through HMI
- 5) Each electrical components of servo system should install inside FFS machine panel
- 6) Photo mark system with tripping relay during error (Milk filling should OFF During photo cell Error)
- 7) Performance report of machine should be available on HMI
- 8) Separate PLC required for each head, i.e. two PLC per machine. PLC also having a facility of further expansion in future.
- 9) One HMI required for Controlling operation of both the Heads (Make :Delta)
- 10) Supplier Should Provide and Fit HMI Cover – Front Side Acrylic & Rear Side –SS304 (As per AFD sample)
- 11) Make of Gear Box –Bonfinglioli. Make of Servo Motor (400Watt) – Delta. Make of Servo Drive (0.4KW)-Delta. Servo Coupler – Transco Make or Equivalent to it.
- 12) Complete operation of machine should operate with the PLC. For that one proximity required for HOME Position.
- 13) We will Provide Existing Electrical Panel Plate of FFS MC to supplier for Fitments of PLC, SERVO DRIVE, Power Supply, SSR, Relay card and other Electrical Accessories with necessary wiring work. Supplier should attend necessary all wiring on Site with Proper Color code of Cables and ferrules.
