We enclose herewith tender inquiry for transportation of Sugar from M/s. Sahakari Khand Udyog Mandli Ltd, Gandevi Dist Navsari to AmulFed Dairy, Bhat Gandhinagar

- Rates must be filled legibly in enclosed rate form only. (Annexure II).
- Our annual sugar lifting from sugar mill is 8000 MT approximate. It may vary as per actual requirement of AFD.
- **EMD & Tender Fee:** You will have to deposit Rs.75000/- for EMD and Rs.5000/- for Tender fee separately by way of RTGS/NEFT in following A/c.  
"BANK NAME: HDFC BANK, ACCOUNT NAME: AMULFED DAIRY (A UNIT OF GCMMF LTD), A/C NO: 00060310001593, BRANCH: NAVRANGPURA, IFSC CODE: HDFC0000006". In case your quotation is not accepted the EMD will be refunded within a month from the date of finalization. EMD will carry no interest. In the event of non acceptance of contract by transporter EMD will be forfeited
- Rewriting / Over writing in tender must be avoided.
- Transporters / Contractors are abide by & bound to follow all the terms, conditions mentioned here in this tender.
- All pages of tender including rate form must be signed & sealed by transporters/ contractors which are considered as your acceptance for all rates, terms & conditions mentioned in tender.
- Management reserves the rights to accept or reject the any / all offers submitted by bidders/award contract on multiple transporters, without assigning any reasons. Management decision in these regards would be considered as final and no complaints will be entertained. No telephonic/personal follow-up from your side will be entertained. Canvassing in any form may lead to disqualification.

## **Annexure: I**

### **Terms & Conditions for Transportation of Sugar Contract :-**

- 1. Period of the contract would be from 1<sup>st</sup> July 2021 to 30<sup>th</sup> June 2023**
- 2. Eligibility Criteria of Transporter:** Transporters meeting following conditions are eligible for take part in tendering process.
  - A** Transporter shall have experience of minimum 3 years for providing of transport service and shall have served at least 3 repute customers
  - B** Transporter shall have minimum 3 nos of 16 Mt or more capacity own trucks
  - C** Transporter's last year turn over shall be 40 lac and above

**Transporters not meeting above criteria need not to apply.**

  - D** Transporter who's performance was not satisfactory in past at AFD and served with multiple notices also need not to apply
- 3. The offer should be sent in sealed envelope super scribing top left corner "AFD: PUR: ENQ:2021:421" . The offer should reach at AmulFed Dairy, Village: Bhat Dist. Gandhinagar latest by 05:00 PM, June 12<sup>th</sup> , 2021.**
- 4. If in extreme case, it is required for calculating Price increase/decrease in Per Trip charges at the time of fuel price increase/decrease after date of contract /order/agreement are to be calculated on the basis of kilometer in tender plus taking 3.0 km/liter as average for 25 MT capacity vehicles to be supplied. This clause is applicable as there is change in fuel rates higher or lower side aggregately by Rs. 2.00/per liter of diesel price from the date of finalized the contract. For this rate of diesel on 1<sup>st</sup> of every month at Gujarat State civil supplies, Kalpataru filling station sector 21 , Gandhinagar will be considered**
- 5. Rates should be quoted on per trip basis, including all road formalities like toll tax etc. in the attached format at Annexure-1 only.**
- 6. The delivery of Sugar should be on FOR AmulFed Dairy, Nr. Indira Bridge, Village Bhat, Dist. Gandhinagar basis.**
- 7. You will submit transportation bills on every 1<sup>st</sup> and 16<sup>th</sup> of every month. Payment will be made within 15 days from the date of submission of your bill by Cheque/RTGS/Bank transfer. No cash payment will be made at Dairy.**
- 8. Transport co. shall take full insurance policy for truck provided. In addition to this liability for the taxes of RTO shall be borne by transporter. All toll tax/ road tax/ bridge tax etc.. will be borne by the transporter. Sugar loading charges at sugar mill is also be born by transporter**
- 9. Transportation rate for transporting sugar would be for net of 25 MT . AmulFed Dairy shall pay proportionately extra for the sugar transported in excess of 25 MT. Small trucks less than 16 MT will not be accepted. For variation on either side in lifting quantity, payment would be given on pro rata basis, taking base of rate pro- rata basis(Rate x Actual Qty/25MT). Payment of sugar transportation other than destination covered under this contract(Bardoli sugar factory 280 km/Maroli sugar factory 286 km/Narmada sugar factory 201 km/Ganesh sugar factory 223 km/Sayan and Kamrej sugar factory 251km/Chalthan**

sugar factory 266 km) would be paid on pro- rata basis, by taking base of approved rate of Sahakari khand udyog mandali ltd- Gandevi, Dist Navsari . For this purpose, approved distance of Sahakari khand udyog mandali Ltd Gandevi to AmulFed Dairy is 310 km will be considered as a base rate.

10. Offer received after due date for whatsoever reason may be summarily rejected. AmulFed Dairy shall have the right to accept or reject any tender without assigning any reason. AmulFed Dairy reserves the right to give 15 days notice to transporter for termination of contract without assigning reason.
11. For any shortages reported or if any qualitative defects found, an equivalent amount shall be deducted from your bills.
12. You shall submit additional Bank Guarantee of any Indian nationalized bank/ security deposit of Rs. 35,000/= **on the award of contract.** AmulFed Dairy shall not pay any interest on SD during or after the contract. EMD/SD should be deposited by RTGS/NEFT "BANK NAME: HDFC BANK, ACCOUNT NAME: AMULFED DAIRY (A UNIT OF GCMMF LTD), A/C NO: 00060310001593, BRANCH: NAVRANGPURA, IFSC CODE: HDFC0000006."
13. EMD and SD will be refunded back only after successful completion of contract on demand/request of the vendor. In the event of non compliance of contract EMD and SD will be forfeited
14. Transporter shall make their own arrangement for transportation of sugar in case of any break down of running truck i.e. truck in transit/ on road trucks
15. Liabilities for employees hired by transporter shall be borne by transporter. Employee of transport contractor should not possess or smoke, eat pan masala or liquor etc. within dairy premises. If any employee violate this rule, AmulFed Dairy will charge Rs. 5000/as decided by management time to time as penalty, which will be recovered from transporter's bill no entry of such employee . Kindly note that AmulFed Dairy is a no smoking zone. AFD has IMS (Integrated Management System ) QMS ISO-9001 :2015, EMS:ISO:14001:2015, FSSC 22000 ver. 5.1 certified Dairy. We are also committed for food safety and human safety on highest basis.
16. Transporter will ensure to depute vehicles as per the schedule / instruction provided by AmulFed Dairy/GCMMF officials from time to time.
17. In case of failure of transport of Sugar in time and any kind of loss incurred to AmulFed Dairy shall be recovered from bill of transporter or SD, whichever is applicable. We might hire outside transporter in case of your failure and recover the transport charges from you.
18. For employees hired by transporter, all legal & criminal liability shall be borne by transporter.
19. Transporter shall provide details like Name & address of their employees to AmulFed Dairy. Transporter shall provide their own Identity Card to their employees. AmulFed Dairy shall allow only these employees.
20. Transporter will be responsible to observe formalities required to be completed at concerned check post, & ensure that there is no default. Taxes as per RTO norms, duty fee, Toll Tax, Road Tax etc. shall be transporter responsibility. M-pass notices / Summons if any served in future by AMC regarding your trucks will be recovered from your Invoices. We will also recover TA/DA paid to our officers for doing such work on your behalf.
21. Quality of Sugar should be pure & unadulterated, this responsibility lies on transporter.

22. If AmulFed Dairy stops Sugar transportation for any reason, AmulFed Dairy will not pay any demurrage charges or rebate to transporter for the consequences if any.
23. Trips are purely based on business allocated by our head office G.C.M.M.F Ltd. Anand.
24. Sugar loading charges at Sugar Mills to be born by transporter
25. All vehicles should be valid PUC certified/with valid driving license and environment friendly as AmulFed Dairy is QMS ISO-9001: 2015, EMS:ISO – 14001:2015 and FSSC – 22000 Ver. 5.1 certified unit. In the interest of sustainable environment, we urge you to deploy eco-friendly trucks.
26. Decision of General Manager , AmulFed Dairy will be final & binding on transporter.
27. Ahmedabad jurisdiction shall be applicable for any discrepancies or dispute.
28. In case of any dispute arrives, will be sorted out by mutual discussion only.
29. **Special Notes:** You have to ensure that EMD amount must have reflected in our account before tender submission time. You have to provide RTGS/NEFT details to AFD in advance before tender submission like UTR no. AFD shall not accept tender without require information. Any delay in deposition EMD by electronic mode/NEFT/RTGS shall be your responsibility
