- Before submitting the tender, contractor may visit the PFP – Gandhinagar to see the waste **PRINTED AND UNPRINTED FILM-TRIM WASTE**. The trim almost contains unprinted film having little printed line or dots on the trims which is sold as an unprinted film waste.

Please read the following terms carefully and submit your most lucrative offers to us in the enclosed format in Annexure II:

1 The contract period will be for the above mentioned period. The tenders duly filled, sealed and superscripted as “**AFD: PUR: ENQ: 2021: 0522** ” should reach to General Manager, Amulfed Dairy, Bhat, Gandhinagar on or before – 19.07.2021 @ 14:30 hrs. Only sealed offers will be accepted.

2 Vendor have to deploy minimum one vehicle (3 -4 MT) to lift the available poly scrap (Printed / Unprinted) on daily basis. In case of non deployment of vehicle Rs.5000/ day (except Sunday) will be charge as a penalty.

3 Vehicle will be taken inside the plant for loading only after sufficient balance for one vehicle gets reflected in our system. Those necessary funds should reflect in our bank account by 1.00 pm then only the said vehicle will be able to dispatch on same day.

4 The bidder must have valid and in force Pollution Control Board Registration/Certificate for disposal/ recycling of waste material being lifted from PFP/AFD.

Copy of such Registration/ certificate must be submitted to AFD along with the tender and on the award of contract to PFP Gandhinagar also.

" In case bidder do not meet minimum legal/statutory requirement required by AFD, offer will be stands rejected.In such cases a token penalty will be levied, as per AFD management discretion (Maximum up to Rs. 5000/-)."

5 Any applicable Taxes, Excise, cess levies etc. on these items will have to be borne by the contractor and the rates shall be quoted EXCLUSIVE of all applicable taxes. If Government adds additional taxes, levies during contract period, same would also be applicable & chargeable to bidder automatically.

- 7 EMD of successful bidders shall be converted into Caution Money (Security Deposit) Deposit on signing of contract. EMD of unsuccessful bidders shall be refunded without any interest, within 45 days from the date of finalization of the contract. In case successful bidders, does not turn out for signing the contract or does not respond to the contract, the EMD already paid shall be forfeited and no claim will be entertained and decision of General Manager, Amulfed Dairy shall be considered as final.
- 8 Successful bidder will have to submit us **additional security deposit** in form of Demand Draft /RTGS transfer equivalent to Rs. 500,000/- each for printed film waste and unprinted film – trim waste in favor of “Amulfed Dairy, A Unit of G.C.M.M.F Ltd.” DD should be payable at AHMEDBAD of any Nationalized Bank or some reputed private banks like Axis Bank, HDFC Banks, ICICI, Yes Bank, Ratnakar, DCB bank, Kotak Mahindra, Deutsch Bank only. It may vary on decision of the allocation of the quantity and can be reduced on pro-rata basis. However it will be minimum Rs 200,000/- irrespective of the allotment.
- 9 The bidder must give his own FAX No., active email ID, land line number and mobile number of the authorized person for communication. If provided information is not clear OR inadequate, then Amulfed Dairy reserves right to cancel the bid. After awarding the contract, the contractor must maintain these communication facilities, failing to do so the contractor shall be penalized @ Rs. 5,000/- or it may even result in the termination of the contract.
- 10 Name, Address, telephone No., Email, FAX of two reputed references of respected Citizen of India like Doctor, Lawyer, Engineers etc. must be given along with the bid itself. The bid may not be considered without these references.
- 11 On an average there will be 6 to 8 MT unprinted + Trim waste and approx to 20 to 25 MT printed waste per week. Based on these PFP/AFD will communicate the contractor through FAX or email only to lift the waste subject to availability of material at our site. Quantity may increase/ decrease

subject to availability. After receipts of communication from PFP, very next day contractor must arrange for DD or the RTGS of necessary amount and vehicle before 4 pm failing which penalty @ Rs. 5000/- per day will be charged.

This amount will be recovered from the amount payable/ security deposit or separate debit note would be raised. In nut shell, it would be primary responsibility of contractor to keep PFP unit & Amulfed Dairy free of scrap material.

- 12 We reserve our right to finalize the contract on time frame basis or quantity basis, as deemed fit by management
- 13 The sale of plastic film waste rate will vary based on the average basic Ex Depot (Sanand) rate of RIL LDPE (1005FY20) and Ex ahmedabad of RIL Octene (O19010). Base of current rate of LDPE – 1005FY20 grade is Rs.123.41 / kg and O19010 is @ Rs. 108.18 /Kg w.e.f. 08.07.2021(Ril circular) . However, applicable actual base rate of above mentioned grades as applicable shall be considered at the time of awarding of the contract.

As and when there is change in rates of both the grades either upward or downward, prorate effect per kg. Will be effective after two days after declaration of M/s. RIL price circular. For example, if the new rates are declared by M/s RIL on 01st month then the new rates for scrap sale shall be made effective from 03rd day of month based on % of rate offered with respect to average basic rate of (1005FY20)LDPE &(O19010) LLDPE. Contractor will have to deposit the amount accordingly.

- 14 The printed / unprinted film – trim waste should be lifted from the premises of PFP, Sector 25, GIDC, Gandhinagar, on "**AS IS WHERE IS BASIS**" by you at your expense. No segregation of the material will be allowed at our premise while lifting of the material.
- 15 At the time of lifting the material for Amulfed Dairy & PFP, all types of weightment, counting, measurements and loading would be done in the presence of our authorized person & the same shall be considered as final.
- 16 The terms and conditions mentioned here would be the integral part of the contract being executed between the parties. Amulfed Dairy reserves the right to extend the period if necessary, on the same terms and conditions.
- 17 The amount of material to be collected as well as the applicable Tax amount should be deposited by DD/RTGS at Amulfed Dairy Account's department. The necessary receipt should be produced via email to accounts department mentioning unique transaction number and then only you will be allowed to lift the printed waste/ unprinted film – trim waste from PFP.
- 18 The contractor will take due care in performance of the contracted work in time & shall engage adequate personnel to ensure the same. The contractor will have to abide by the directives of the Amulfed Dairy & PFP with regard to the conduct and movement of his workmen in respective premises.
- 19 The contractor shall be responsible for any loss/damage to the properties of Amulfed Dairy/PFP caused by the workmen engaged by them.
- 20 The Contractor has to remove and replace the workers who are found to be undesirable by the Amulfed Dairy. The Contractor shall be solely responsible for the acts of omission and commission

of his workmen deployed for carrying out this work and shall indemnify the Amulfed Dairy against any damage to property and injury to limbs and loss of life of person(s) arising out of negligence and carelessness on the part of his workmen while carrying out his work and the cost of such damage/loss shall be recovered from the contractor.

- 21 The Contractor will be responsible for any Govt. rules and laws applicable in connection with their workmen and Amulfed Dairy/ PFP will not be responsible for the same.
- 22 **The printed and unprinted film - trim waste shall be lifted as per schedule without fail. If same is not lifted as per schedule given, the same shall be disposed off by us at prevailing prices & loss occurred due to this to Amulfed Dairy in price, transportation, loading etc. shall be recovered from Security Deposit.**
- 23 Amulfed Dairy would be free to engage workers from outside or/otherwise to the work, in the event of contractor, fails to perform the task and all cost, damages, if any on this behalf shall be entirely to the account of the contractor as explained above.
- 24 During the contract, if the performance of the contractor is not satisfactory then contract can be cancelled after giving two (2) Regd. A.D. written notices & in such cases the EMD /(SD) CMD will be forfeited.
- 25 Parties/ Vendors, which were blacklisted by Amulfed Dairy earlier cannot participate in the bidding process, however if it comes to knowledge of Amulfed Dairy that such blacklisted Parties/ Vendors have submitted offers by other names or sister concern, their bid shall not be considered and shall be rejected summarily without assigning any reason.
- 26 We are an IMS (ISO 9001:2008, ISO 14001:2004 and ISO 22000:2005) certified unit. We follow eco-friendly processes, which helps in sustainable & safe up keeping of an environment. We expect similar procedure to be followed in your unit. Please ensure maximum recycling of material lifted from PFP/Amulfed Dairy.
- 27 You will ensure that scrap materials lifted from Amulfed Dairy and PFP are not used in harmful activities for environment. You shall submit in writing disposal plan for the material being lifted from Amulfed Dairy and PFP.
- 28 General Manager, AmulFed Dairy reserves the right to cancel/terminate the contract, even after awarding the contract, without assigning any reason & same shall be binding to the contractor/bidder.
- 29 Any dispute between the contractor and the Amulfed Dairy will be settled by mutual negotiations only and the decision of the General Manger of Amulfed Dairy shall be considered as final and binding on both the parties. In case a legal settlement is resorted to as a last refuge, the jurisdiction of such settlement will be Ahmedabad only.
- 30 We reserve our right to extend the contract further by 3 months or increase or decrease the quantity allotted as per the contracted rates and terms with mutual consent. Decision of GM shall be considered as final& binding to all concerren parties.
